Usage Guidelines

Placement: Place containers in areas that achieve desired supplement intake. Move containers to underutilized pasture areas once acceptable intake levels are achieved.

Relocation: Move containers to underutilized pasture areas once acceptable intake levels are achieved.

Accessibility: A minimum of two containers may be necessary in each lot or pasture.

Quantity: One container for every 20-30 head. Consumption: 0.5 and 1.1 pounds per head per day.

Monitoring: Consumption depends on animal size, weather conditions, and quality of other feeds.
