Ingredients

Molasses products, processed grain by-products, plant protein products, monocalcium phosphate, dicalcium phosphate, hydrolyzed vegetable oil, calcium carbonate, magnesium oxide, zinc oxide, manganous oxide, ethylenediamine dihydroiodide, ferrous sulfate, cobalt carbonate, selenium yeast, vitamin A supplement, vitamin D3 supplement and mineral oil.

Usage Guidelines

Placement: Place containers in areas that achieve desired supplement intake

Relocation: Once acceptable intake levels have been achieved, the containers may be moved to underutilized pasture areas to improve grazing distribution and forage utilization

Accessibility: A minimum of two (2) containers may be necessary in each lot or pasture to ensure proper accessibility

Quantity: Feed at the rate of one container for every 20-30 head of cattle, equines and bison, and 10-20 head of sheep and goats

Monitoring: Self-fed consumption will depend on size of the animals fed, seasonal weather conditions, as well as quality, source and availability of other feeds

CAUTION: Consumption of selenium should not exceed 3 mg per head per day for cattle, bison and equines and 0.7 mg daily for sheep and goats. CAUTION: Equines must be managed so that consumption of this block does not exceed three (3) pounds per head per day.
